

Board Director

The Role

The LiverWELL Board is seeking to appoint a dynamic Board Director committed to LiverWELL's vision, mission and values, who shares our passion to see LiverWELL grow and continue to improve the liver health for all in Victoria. The Director will be one of up to 12 Board members who provide corporate governance to LiverWELL, a company limited by guarantee (ACN 634 668 205). LiverWELL is registered as a charity with the Australian Charities and Not-for-profits Commission, and trades as both LiverWELL and as Hepatitis Victoria.

The Director will sit as a full Board member and be committed to attend where possible all Board meetings – each 6 weeks – and to actively participate on Board sub-committees. A minimum of 75% attendance at Board meetings is required. They will also participate in other governance processes and obligations and have the opportunity to be involved in additional events. Full orientation and Board 'buddying' system is available.
